Okuvikelwe

Uma ingxenye evikelekile ngaphansi kwalo mshuwalensi isikhokhile inkokhelo yanyanga zonke yendlu enemitha yokukala amanzi ngesilinganiso esivezwae kukesi sikweletu sakwa ETHEKWINI WATER SERVICES, iNkampani izokhokha izindleko zengxenye evikelwe ngumshwalensi sonke isamba esimelwe sikhokhwe yiyo ngokusemthethweni ngenxa yokulahlekelwa ngamanzi okwenzeke kungalindelwe uma kwenzekha lokhu okulandelayo:

1. Ukuvuza kwamanzi okungahlosiwe okwenzekha ngaphansi empayipini emva kokufakelwa kwemitha yokukala amanzi kumbe ukuthomba noma ukuguga kwamapayipi.
2. Ukuqhuma kwamapayipi ngaphansi noma ngaphezu komhlaba uma kwenziwe ngabaqashiwe bangaphandle uma evikelwe ngumshwalensi –
 - a) engasayinga isivumelwano esidlulisela amalungelo komunye umuntu.
 - b) ngakhangama sivumelwano nomunye umuntu ngaphandle kwemvume yeNkampani.
 - c) nganikeza iNkampani amalungelo okukhulumisana nalowo muntu.

Isimo Esingekwe Sakhokhelwa

Inkampani ngeke ikhokhe uma ukulahleka kwamanzi kudaleke ngendlela eqondile noma ngandlela thize yilokhu okulandelayo:

1. ukumbeka noma ukubhidlika komhlabathi.
2. ukugcwaliswa kwamadamu okubhukuda , amadamu, iziziba ezingadala ukuvuza, noma okunye okufana nakho.
3. ukwenza ngesibomu komnini muzi ovikelwe wumshwalensi , noma yimuphi umuntu owenza lesa senzo egameni lakhe esidala ukuvuza kwamanzi.
4. ukuxhonywa kwamanzi okungavumelani nemibandela emiswe nguMnyango wezaMasipala wendawo.

Isisekelo Noma Isimiso Sokukhokha

1. Inani lenkokhelo egcwele yokulahlekelwa kwamanzi ngezikhathi zokuvuza, okuphidwe kabili (2) kubalwa nezindleko zokwenza umsebenzi , eziyintela ebizwe ngabenzi bomsebenzi kulowo ovikelekile.
2. Izindleko zokwenza umsebenzi zilinganiselwa kulezo zindleko ezigxile kumthamo wamanzi osemitheni.
3. Isikhathi sesilinganiso semitha, yisikhathi esiphakathi kwezilinganiso ezimbili (2) ezilandelayo kukhiswe izikhathi ezedule zokufakwa zokuvuza kwamanzi zokukhokhelwa. Izikhathi zokuvuza kwamanzi zingachazwa njengezikhathi zokukalwa kwezilinganiso semitha masinyane phambi kosuku lokulungiswa kokuvuza kanye nesikhathi sokukalwa kwesilinganiso semitha emva kokulungiswa. Isikhathi sokukalwa kwesilinganiso samanzi ukuba yizinsuku ezingamashumi amathathu (30days) ngasinye, kodwa qaphela ,lezi zikhathi zokukalwa kwamanzi angeke zeqe inani lezinsuku ezingamashumi ayisithupha nanhlano (65 days) uma zihlanganiswa ndawonye.
4. Uma kwenzeka ukuthi kube yindawo entsha lapho kungakaze kukalwe khona amanzi ngaphambili, omele omkhandlu wendawo kanye noboMshuwalensi bazonquma isilinganiso samanzi alahlekile emva kokucubungula imininingwane efanele. Isilinganiso samanzi esilandelayo esimele ukusetshenziswa okujwayelekile noma amanzi asetshenziswa ngenkathi kuxhonywa amapayipi amanzi.
5. Ukukalwa kwesilinganiso samanzi asetshenziswa nsukuzonke esilandelayo sibalwa ngokuhlanganisa ndawonye amanzi asetshenziswa nsukuzonke ezilinganiso ezintathu (3) masinyane phambi kwesikhathi sokuvuza kwamanzi bese zihlukaniswa kathathu (3).
 - a) Uma kwenzeka ukuthi akukho sikhathi isilinganiso samanzi singaphansi kwezintathu, kodwa okungenani isikhathi esisodwa ngaphambi kokuvuza kwamanzi, asetshenziswe ezinsukwini ezilandela lezo, azobalwa phezu kwesilinganiso samanzi esikhona.

- b) Isinxephezelo sokuvuza ngakodwa kwazo zombili izikhathi kuyobalwa ngokwahlukana bese ziyahlanganiswa ukufinyelela kwesinxephezelo esifanele esiphelele. Ukulahleka kwamamzi zobalwa ngomehlukho phakathi kwamanzi asetshenziswa nsukuzonke ngenkathi kusavuzwa kanye nesilinganiso esilandelayo samanzi sansukuzonke kuphindaphindwe ngesibalo sezinsuku ngenkathi kuvuza.

Ukukhishwa Kwemali Yezicelo Zenkokhelo

Inkampani yomshuwalensi izokhokha zonke izimali ezidingwa yingxenye evikelwe wumshwalensi ngokulandela imigomo yalo mshwalensi ngokumayelana nezindleko zamanzi avuzile kanye nezindleko zokusebenza kwi-ETHEKWINI WATER & SANITATION ezobe isikhokhela ovikelekile isikweletu sengxenye evikelwe wumshwalensi.

Ukuqwedwa kwesivumelwano

Ovikelwe wumshwalensi angaqeda isivumelwano anaso esikimini somshwalensi ngokufaka inothi ebhalwe phansi yezinsuku ezingamashumi amathathu (30 days) kuMqondisi waManzi ngenhloso yakhe yokwenza njalo.

Imibandela Emiswe

1. Zonke izicelo zenkokhelo mazifakwe efomini efanele yezicelo etholalaka emahhovisi akwa-ETHEKWINI WATER SERVICES ngaphambi kokuphela kwezinsuku ezingamashumi ayisithupha (60 days) kusukela osukwini lokulungiswa kokuvuza kwamanzi, ngaphandle kwalokho isicelo ngeke sihlangatshewe.
2. Isinxephezelo ngaphansi kwalo mshuwalensi ngeke sibhekele izindleko zokuvuza kwamanzi, kanye nezindleko zokusebenza , ngenxa yokuvuza kwamanzi okungaphansi komhlabathi futhi ukuvuza kungabonakali ngendlela ecacile.
3. Kumele umninimuzi aqikelele ukuthatha izinyathelo ezidingekile ukunciphisa noma ukuqeda ukuvuza kwamanzi masinyane emva kokuba esebonile ukuthi amanzi ayavuzwa.
4. Umsebenzi wokuvala ukuvuza owenziwe ngabantu ababhaliswe kwi-ETHEKWINI WATER SERVICES uzoholwa ngupulamba oqokwe yiNkampani ezobiza ngokwenza lomsebenzi imali engu- R100.00 ezohlehlulwa kwisamba sesinxephezelo. Isiliphu sesikweletu sikapulamba esikhombisa ngokucacile usuku umsebenzi owenziwa ngalo kufanele sifakwe ndawonye nefomi lesicelo senkokhelo.
5. Inkampani angeke ikhokhe izikhathi ezingaphezu kwezimbili esikhathini esiyizinyanga eziyishuminambili (12 months) noma imali yezidleko zamanzi ngaphezu kwezicelo zamalitha angu 4000 kanye nanoma yiziphi izindleko zokwenza umsebenzi ezibizwe ngesikhathi sokuvuza kwamanzi.
6. Phezu kwayo yonke imibandela kanye nezimo, isinxephezelo ngaphansi kwalo mshuwalensi sizokhokhwa uma imali ekhokhwa nyangazonke yomshuwalansi ikhokhiwe ngesikhathi sesilinganiso esithintekile, noma ingxenye yaso ngesikhathi esingaphansi kwaleso.
7. Inkampani inelungelo lokumisa noma isule umshwalensi uma ukufakwa kwamanzi kubonakala sengathi akwenziwanga kahle.
8. Umbhalo ongesiNgisi yiwona oyosebenza uma khona isingqinamba mayelana nokuhunyushwa kwamagama enqubo mgomo.
